TO THE HONORABLE BOARD OF EXAMINERS OF SAID COUNTY :

Your petitioner Sarah A. Rainwater respectfully represents to your Honorable Board, that she is a citizen of Marshall County, in the State of Alabama, and was such on the 1st day of January, 1899; that she is the widow of U. P. Rainwaters, who served as a Private in Company B of the 21 Regiment Ga Volunteers; that her husband ~~was killed~~, or died, on the 8 day of July, 1877; that he did not desert the service of the State of Alabama, nor of the Confederate States; that she has not since remarried; that she has no children upon whom she can depend for support; that all of her property does not exceed Four Hundred Dollars in value; and that her annual income from all sources does not exceed Four Hundred Dollars. She therefore respectfully asks your Honorable Board to place her name upon the pension rolls of the State as a member of the fourth class, that she may participate in the division of the fund provided for the relief of needy Confederate soldiers and sailors, and their widows, by an act of the General Assembly of Alabama, approved February 10, 1899.
